### 1. Purpose of this document

The purpose of this Code of Practice document is to outline the procedure for the issuing of Catch Certificates, Processing Statements and Storage Documents required for exports, when requested by the point of destination, or travelling to certain countries that automatically request certification, or when produce is being processed in a third country and returning to the EU thereafter.

Catch Certificates, Processing Statements and Storage Documents are validated and issued by the Sea-Fisheries Protection Authority (SFPA), the competent authority under Irish and European legislation. These export documents will not be required where fishery produce is being exported within the European Union.

#### 1.1 Audience for this document

- Exporters
- Food Business Operators
- Agents (referred to as applicants)



### 2.1 Procedure

An Exporter, Food Business Operator or Agent who requires a Catch Certificate for export to third countries must give reasonable notice to the SFPA port that has responsibility for the vessel/premises. A <u>minimum of 24 hours'</u> notice must be provided to allow sufficient time prior to the export of the consignment for the SFPO to complete the relevant documentary checks to issue the Catch Certificate and/or to make any necessary administrative enquiries. The 24-hour timeframe commences when the application is submitted through the ECS system.

Please note that weekends/public holidays may affect Catch Certificate processing timeframes.

The timeframe outlined above will not apply to the processing of Processing Statements or Storage Documents, please ensure to allow for sufficient time in advance of export for these applications to be validated.

Catch Certificates, Processing Statements and Storage Documents can be applied for through the Export Certificate System (ECS). Applications can be made as a Registered User or an Anonymous User.
